

TERMS AND CONDITIONS – MENTA '25

1. General Provisions

1.1 Purpose and Scope of This Document

These Terms and Conditions (the "Terms") detail the participation requirements for the MENTA '25 conference (the "Event"), the legal relationship between the organizer and participants, and the rights and obligations of all parties.

These Terms are effective from January 1, 2025, until revoked.

1.4 Definitions

Participant: Any individual attending the Event, regardless of whether they or a third party paid the participation fee.

Ticket Purchaser: The individual or legal entity who purchases a ticket to the Event.

Ticket: A personalized, non-transferable document (electronic or printed) that grants access to the Event.

Participation Fee: The amount payable for Event attendance, varying by ticket type.

Event Partner: A partner involved in organizing the Event.

2. Contract Formation

2.1 How the Contract is Formed

A contract between the Organizer and Ticket Purchaser is formed upon ticket purchase. Tickets are purchased through www.menta.ivalsz.hu by completing the registration form and successfully completing the payment process.

2.2 Contract Language

The contract is formed in Hungarian.

2.3 Contract Format

This is an electronic contract governed by Hungarian Act CVIII of 2001 on electronic commerce services and information society services.

2.4 Contract Recording

The contract is not filed and exists only in electronic form, and cannot be retrieved later.

3. Registration and Ticket Purchase

3.1 Registration Process

Event registration occurs through www.menta.ivalsz.hu following these steps:

1. Select ticket type
2. Provide personal information
3. Provide billing information
4. Choose payment method
5. Accept data processing notice and participation terms
6. Review and confirm order
7. Payment

3.2 Ticket Types and Prices

The following ticket types are available:

Conference Ticket + Evening Reception: Includes conference participation, coffee breaks, lunch, evening reception, and all associated beverage packages. Limited availability.

- Early Bird Price: 149,900 HUF + VAT
- Standard Period Price: 174,900 HUF + VAT

*Conference Ticket + Evening Reception (IVSZ Members):** Includes conference participation, coffee breaks, lunch, evening reception, and all associated beverage packages. Limited availability.

- Early Bird Price: 96,900 HUF + VAT
- Standard Period Price: 112,900 HUF + VAT

Conference Ticket (Without Evening Reception): Includes full conference program participation (9:00 AM - 6:00 PM), coffee breaks, lunch, and non-alcoholic beverage package.

- Early Bird Price: 109,900 HUF + VAT
- Standard Period Price: 129,900 HUF + VAT

*Conference Ticket for IVSZ Members (Without Evening Reception):** Includes full conference program participation (9:00 AM - 6:00 PM), coffee breaks, lunch, and non-alcoholic beverage package.

- Early Bird Price: 71,900 HUF + VAT
- Standard Period Price: 84,900 HUF + VAT

*ATTENTION! IVSZ member discounts require that the member organization has no outstanding membership dues.

Conference participation fees include costs for the one-day event (9:00 AM - 6:00 PM programs). Taxes and contributions according to applicable laws must be paid by the participant.

All listed prices are net prices and do not include 27% VAT.

3.3 Payment Methods

Participation fees can be paid using:

1. **Credit Card Payment:** Through the SimplePay online payment system
2. **Bank Transfer:** Based on the system-generated invoice following registration, transferred to the specified bank account

3.4 Invoicing

Following payment, the organizer issues an electronic invoice sent to the email address provided during registration. The invoice contains mediated services. Any tax and contribution obligations arising from the catering services named in the invoice must be borne by the service recipient.

3.5 Ticket Validity and Use

Tickets are personalized and non-transferable. Participants must provide identification when entering the Event. Tickets allow single entry only; leaving the Event premises invalidates the ticket unless the Organizer determines otherwise.

4. Cancellation and Modification Terms

4.1 Participant Cancellation

Participants may cancel their registration under the following conditions:

- **Before August 15:** Full refund of participation fee
- **August 15 - September 10:** 50% refund of participation fee
- **After September 10:** No cancellations accepted, no refund available

Cancellations must be submitted in writing to menta@ivsz.hu.

4.2 Participant Data Modifications

Participant data provided during registration may be modified up to 5 business days before the Event by emailing menta@ivsz.hu.

4.3 Event Cancellation or Modification

If the Event is cancelled due to reasons within the Organizer's control, the Organizer must refund the full participation fee to the Ticket Purchaser.

If the Event is cancelled or postponed due to reasons beyond the Organizer's control (force majeure), the Organizer is not obligated to refund participation fees but will ensure ticket validity for the modified date.

The Organizer reserves the right to unilaterally modify the Event's program, venue, date, and other parameters. Changes will be communicated via www.menta.ivsz.hu and the email address provided during registration.

5. Event Participation Rules

5.1 Entry and On-Site Registration

Event entry requires presenting the QR code received during registration, acceptable in electronic form (mobile device) or printed format. The Organizer may verify participant identity upon entry.

On-site registration begins at 8:30 AM on September 30, 2025. The Organizer encourages participants to arrive early for smooth entry.

5.2 Conduct Rules

Participants must behave in a manner that does not disturb other participants or speakers and conforms to general social conduct standards.

The Organizer may remove participants who are disruptive or behave inappropriately from the Event. In such cases, participation fees will not be refunded.

5.3 Photography and Video Recording

The Organizer's authorized photographers and videographers will record the Event, and participants may be recognizable in these recordings. By attending the Event, participants consent to being photographed and recorded, and to the Organizer using these materials for marketing purposes.

The following rules apply to participant-created recordings:

- **Personal Use:** Participants may freely photograph for personal use
- **Social Media Sharing:** Permitted using hashtags #MENTA'25, #MENTA, or #MENTA2025
- **Photographing Others:** Requires consent of those being photographed
- **Business/Marketing Use:** Requires prior written permission from the Organizer
- **Restricted Areas:** VIP area photography is limited; some presentations may prohibit photography at the speaker's request
- **Live Streaming:** Limited live streaming to personal social media is permitted; streaming entire presentations is prohibited

Participants who prefer not to appear in recordings may indicate this during registration or on-site.

5.4 Intellectual Property Rights

Presentations, materials, and documents provided by the Organizer are protected by copyright. Recording, copying, distributing, or otherwise using these materials in whole or in part requires prior written permission from both the Organizer and the presenter.

6. Liability

6.1 Organizer Liability

The Organizer accepts responsibility for professionally organizing and conducting the Event in compliance with applicable laws.

The Organizer is not liable for:

- Personal items brought by participants, including loss, theft, or damage

- Damages caused by participants at the Event venue, for which the participant is directly liable
- Accuracy and authenticity of participant-provided registration data
- Participant conduct at the Event and its consequences
- Damages, delays, or other problems arising from force majeure

6.2 Participant Liability

Participants are responsible for:

- Accuracy of registration data provided
- Their conduct at the Event venue
- Any damages they cause
- Compliance with these Terms and Event house rules

7. Data Processing

The Organizer processes participants' personal data according to the Data Processing Notice available at www.menta.ivalsz.hu.

Participants must accept the Data Processing Notice during registration; registration cannot be completed without agreeing to this.

8. Additional Provisions

8.1 Terms Modification

The Organizer reserves the right to unilaterally modify these Terms. Modifications will be communicated via www.menta.ivalsz.hu. Modified Terms take effect upon website publication.

8.2 Governing Law and Dispute Resolution

These Terms are governed by Hungarian law. Parties will first attempt to resolve disputes amicably. If unsuccessful, parties submit to Hungarian court jurisdiction.

8.3 Severability

If any provision of these Terms proves invalid or unenforceable, it does not affect the validity and enforceability of other provisions.
